

(1) DDS-32, Uniform Traffic Citation, Summons and Accusation, shall be used by all law enforcement officers who are empowered to enforce the traffic laws and ordinances in effect in this State. ~~The version of Form DDS-32 being used as of the effective date of the 2022 amendment to this rule is repealed effective June 30, 2022 and may be used through October 31, 2022.~~ The amended version of Form DDS-32, shown in sections (1)(a) through (1)(e) of this rule, shall be effective July 1, 2023<sup>3</sup> and may be used beginning on July 1, 2023<sup>3</sup>. Such citation shall be by the following form in a five-part series, at least 5 ½ inches in width and 8 ½ inches in length except that computer generated or electronically submitted citations shall not have a series requirement and may appear up to 8 ½ inches in width and 11 inches in length.
